Meeting minutes: Wayne Reese motioned, Amy Huntley seconded accepting the minutes as provided with no changes. Motion carried.

Treasurer's Report: Jane Rock walked through reports for November, December and January. Finances have improved from prior months, and the foundation may have a positive balance after mailing a newsletter (in January) for the first time in years. In the past, it usually took several weeks for enough donations to be received from the newsletter mailing to bring the operating funds back into a positive balance. Scott Maloney motioned, and Amy Huntley seconded accepting the treasurer's report. Motion carried. Wayne Reese moved, and Ginny Hill seconded approving Jane's request that a signature stamp be made of Paul's signature so she can more quickly get out the thank you letters for donations.

Fund raising: The cat's meows are almost gone. The cost to mail them is now \$3.85, for future reference. The Tri-Bay golf outing meetings start in February. Someone suggested they should be held at the new Green Isle restaurant in Bay to support a Bay Village establishment. Paul Hartranft will pass this along to Al Nelson, who usually schedules the meetings. Stacey Caddey has been working on a proposal to move to a membership approach with the newsletters. Wayne Reese will check with her to see if

she can be at the next meeting in February.

Newsletter: The next edition should be out by the end of January, and the deadline for submitting content for the next one is March 1. The content deadlines for the three issues each year are March 1/July 1/November

1.

Hall of Fame: Amy Huntley will follow up with Denny Woods about matching funds raised by the class of 1948 to restore the hall of fame for the alumni group. A spot has now been selected for the hall of fame in the hallway on the West side of the auditorium. Ideally, the Alumni Foundation would like to see a contribution of \$2,000 to \$3,000 from the school district. The class of 1947 would like their \$220 that is currently deposited with the Alumni Foundation to be contributed toward the hall of fame.

Ike Ganyard took pictures of the hallway and he is looking into companies that would oversee the project. He is also working on some designs for the sign that would designate the wall as the Alumni Foundation Hall of Fame.

The group had conversation about how the process to select alumni and teachers needs to be documented and more formalized. Scott Maloney will contact Amy Huntley to get a

copy of procedures for Lakewood's process that were provided to her by Ike, and he will work on a draft to be presented at the February meeting for consideration. Paul Hartranft proposed going back to nominating Teachers of Distinction and Distinguished alumni every year rather than every other year. The recognition of inductees would not have to be tied to an alumni brunch every year, but could perhaps be tied to a cocktail hour, and maybe sponsored by the oldest class having a reunion that year?

The next meeting is February 30, at 7:00 at the KT Allen building.

Acceptance of minutes from prior meeting Judy Norton moved, and Ike Ganyard seconded to accept the minutes from the February meeting. Minutes approved

Finance Committee Jane Rock presented the treasurer's report. Lois Dougherty moved to accept the treasurer's report, and Scott Maloney seconded. Treasurer's report approved.

Communication Committee Amy Rock has requested that all content for the upcoming newsletter should be e-mailed to shoreline@ftgis.com Lori Sisto will get an article to Amy for homecoming weekend. Scott Maloney will get one to her for the Alumni awards.

Special Events Committee Al Nelson gave an update on the upcoming Tri-Bay golf outing. Letters will be mailed to potential sponsors and advertisers by March 15. The last couple years, each of the three groups supported by this event have realized about \$2,200 each! The marketing materials are being worked on by Barb Quinn. Meetings are being held on Tuesday evenings at the Green Island restaurant in Bay Village. Hall of Fame project Ike Ganyard brought the sign to the meeting that will be installed above the entrance to the hallway next to the auditorium at the high school where the new hall of fame will be located. The sign looks great!

Sam Milliken is working on getting a photo from every past inductee, and Gay Menning and Kay Laughlin have agreed to do the write-ups for each plaque. Welcome back! The group agreed we should hang up the old plaques until the new ones are made later this year. Ike will talk to Ron Flowers, the high school custodian, about helping to get the sign and the plaques hung on the walls. Ike has been working with a company called "Partners in Recognition" on a mock-up of what the wall could look like with a new background and plaques. Everyone at the meeting loved the mock-up, and would like to pursue it. Ike asked for some more time, because this is only the first mock-up, and other ideas may surface. The estimated cost to pursue the current proposal would be about \$13,000. About \$6,000 have been committed to the project so far. The group agreed everyone should try to think of alumni who might be in the business of building displays, to see if we might be able to get the wall done for a reduced cost. Scott will write up an article for the upcoming newsletter about the hall of fame project and the proposed mock-up. Scott will also send a letter to the classes that have funds on hand with the Alumni Foundation, presumably for future reunions, to see if they would be willing to donate those funds to the cost of completing the hall of fame. Ike will have more to report next month!

from Tuesday, 6 April 2004

Paul Hartranft called the meeting to order at
7:04 p.m.

Present: Paul Hartranft, Judy Norton, Ginny Hill, Sam Milliken, Wayne Reese,

Trustees Present: Judy Norton and Wayne Reese (no quorum)

Ginny Hill started the meeting by stating that Ike would not attend this meeting due to the recent death of his wife Nancy and that he will resume his Alumni Hall of Fame endeavors at the appropriate time. Paul Hartranft added that an article would be featured in the upcoming **newsletter** expressing the foundation's condolences at the passing of Nancy Ganyard.

Sally Price shifted gears to the Bay Alumni Directory and the fact that her name is not included. This was followed by a brief discussion of other omissions and why this was the case. Paul Hartranft stated that he would confer with Scott Maloney on the matter. Sally's name is in the database, so I am not sure why it would not be in the alumni directory. We've been doing a lot of cleanup in the past couple years, so perhaps Sally's name was not in the database at the time Paul gave the file to Harris? Sorry I can't be more help on this one.

Judy Norton moved that we dispense with a reading from our last meeting's minutes. Seconded by Wayne Reese.

Finance Committee

Jane Rock submitted the March financial statement showing the foundation in the black at \$4,768.35. She added that this figure includes \$770 in Hall of Fame donations since the previous meeting.

Bart Rippl moves to accept the treasurer's report. Seconded by Judy Norton and passed unanimously.

Newsletter

Paul Hartranft stated that the next newsletter (currently at the printer) will cost a bit more due to additional names added to the database since the last newsletter. Based on feedback received to respond to my email asking whether we should exclude classes 1999 through 2003, we chose to do that so the number of mailings will remain under 8,800 like in past mailings. The mailing we do at the end of the summer will be the only one each year that includes all classes. We will have an article in there about this so the recent graduates know they need to make a contribution if they want to see all three issues, or they need to go to the web site to see all three issues.

Special Events

Paul Hartranft emphasized that the Tri-Bay Golf Outing is moving along very nicely. Wayne Reese added that attendance will be significantly higher than last year, as this event is

growing substantially more popular. Paul Hartranft complimented Al Nelson for the fine work and dedication he exhibits in planning and executing this event.

Unfortunately, and for the third year in a row, the foundation had to decline an offer by professional golfer John Daly to conduct a beer bong clinic on the 18th hole.

Fundrai sing

Bart Rippl stated that he and Stacey Caddey had tried to get together to discuss fundraising, but scheduling conflicts has made this difficult. Jane Rock stated that she'd be willing to chip in on a discussion.

Bart Rippl inquired about the proposal by Bill Rammey to approach George Steinbrenner for a foundation donation. This is still a work-in-progress.

Hall of Fame/Distinguished Alumni Awards

Sally Price inquired about a potential Distinguished Alumni award being presented to someone deserving yet who did not graduate from Bay High due to military service (i.e., being drafted during senior year). General consensus seemed to be reached that the foundation needs to set specific criteria for this award. This issue will be revisited once Ike returns. (We miss ya, Ike!!!)

New Business

Wayne Reese provided the foundation with an update on community affairs. Adele Wheeler, Director of Community Services, is retiring after 20 years of dedicated service. An update was given on the Avon Lake/Bay park project, which has a three-year time frame for completion. Wayne mentioned that bids have gone out on construction of a new police station. He also touched on the "contiguous property" debate at city hall (i.e., regarding church expansion) and the need to preserve neighborhoods in Bay. There is a council meeting on April 23 regarding this and Wayne encouraged foundation **members to attend**. Several proposals on the Marathon property are being considered. A May 20th fundraiser for the Village Foundation will include a tribute to Bay Councilman-At-Large Dick Martin. Wayne concluded with an update on city tax matters, such as taxation on lottery winnings, recently discussed by council.

Paul Hartranft touched on the Homecoming Cocktail Party and mentioned that his class is having their 40" reunion this year and that they may be nominating for Distinguished Alumni a well-known author from their class. This was followed by a discussion of the nominating procedure. Jane Rock suggested having this award presented at the Tri-Bay Golf Outing due to the number of attendees this event routinely boasts.

Sam Milliken announced that he's been attempting to locate past alumni award/plaque recipients and asked fellow foundation members for help. Several offered their assistance.

Paul Hartranft opened the meeting by stating that the foundation had received a check in the amount of \$300 from the New York Yankees. He qualified this by adding that the money was for the Tri-Bay Golf Outing.

Paul Hartranft moved that we dispense with the reading of April's meeting minutes. Seconded by Judy Norton.

Finance **Committee**

Jane Rock submitted the treasurer's report showing the foundation in the black at \$2,195.24. She added that the foundation had also received \$250 since the previous Saturday and another \$3,000 today (4 May) earmarked for the Alumni Hall of Fame.

Paul Hartranft motioned that we accept the treasurer's report. Seconded by Bart Rippl and passed unanimously.

Newsletter

Amy Huntley commented that the paper upon which the spring newsletter was printed was much better and most present at the meeting agreed.

The next newsletter will be mailed in August.

Paul Hartranft indicated that, based upon what he has heard, there will be approximately 3 or 4 nominees this year for the Alumni Hall of Fame.

Ike inquired about the protocol for selecting nominees for induction. It was interjected that the Hall of Fame Selection Committee will address this.

Amy Huntley mentioned that Scott Maloney is working on correcting errors and omissions from the latest Alumni Directory. Per Amy, there were misspellings due to information provided by the Harris Publishing database and Paul agreed that this was, in all likelihood, the primary source of the errors. Harris is looking into this and a representative from the company will be contacting Paul Hartranft on the matter.

Special Events

Paul Hartranft stated that the Tri-Bay Golf Outing is moving forward positively and that the committee spearheading this fundraiser is meeting every two weeks. He added that sponsorship is down from last year, although there will be plenty of golfers nevertheless.

Amy Huntley shifted gears by announcing that alumni are encouraged this year to again participate in speaking to Normandy Elementary School 2nd graders on the history of Bay Village. This **was done last year and was very favorably received** both by the students and the teachers. Teachers this year suggested a four subject format (government, transportation, etc.) and the dates will be May 19 and 20. Sam Milliken, George Serb and Wayne Reese will **participate this year and other alumni are encouraged to join**. Those wishing to participate should attend a coordination meeting on Thursday, 13 May at 7 p.m. at the Board of Education building. Bring any props or pictures you have to this meeting.

Fundraising

Stacy Caddey presented a six-step alumni membership implementation program in an effort to get the foundation's fundraising in gear. Highlights of these steps include establishing a timeline for implementing this program, naming membership levels and drafting a membership policy regarding how membership will affect the mailing list and inclusion in newsletter mailings.

The fundraising committee now includes Stacy Caddey, Bart Rippl, Paul Hartranft, Jane Rock, Wayne Reese, Judy Norton and Tom Phillips

Bart Rippl emphasized that it is imperative that fundraising begin in earnest so that, **five years from now, the foundation** still is not living hand-to-mouth.

Hall of Fame/Distinguished Alumni Awards

Ike Ganyard stated that there should be a repository for all past issues of "The

Shoreline". Sam Milliken volunteered to keep the copies with him and it was also suggested that they be stored at the Board of Education building.

Ike added that he needs a copy of the Hall of Fame proposal generated by Partners in Recognition from either Scott Maloney or Lori Sisto, as he would like to show this proposal to Mike Jelinik.

Currently, per Ike, Gay and Kay are working on plaque captions. Also, the Hall of Fame sign will be going up at the entrance to the west auditorium very soon. Ike hopes to get started on the plaques by mid summer **and tentatively** plans on the hall being open for visitors by homecoming '04.

Alumni Foundation Membership

Wayne Reese suggesting sending out invitations, with R.S.V.P., prior to our July meeting/cookout to **get more people** involved in the foundation. **There was no clear consensus**

regarding to whom these invitations should be sent, plus there is the issue of expense. Bart Rippl suggested that a handful of invitations be printed and given to current foundation **participants at the June meeting to be handed out**, on an individual basis, to family and friends who attended Bay High. The July meeting/cookout is scheduled for Tuesday, July 13 at 6:30 p.m. at Baycrafters.

New Business

Amy Huntley announced that the decommissioning ceremony for Forestview Elementary School will be Saturday, May 8 at 10 a.m. She added that demolition begins the following Monday, May 10.

Old Business

George Serb handed out additional copies of the Winter 2004 "School News" newsletter which **featured a cover** story on the old and new Bay Middle School. It was generally suspected by foundation members present that the only reason George did this was to show off his 1933 senior picture, which was prominently displayed on

the newsletter's front cover. We're on to ya, George!!!

Sally Price critiqued the previous newsletter's lack of photos and added that there was too much print devoted to fundraising. All foundation members are encouraged to provide photos and non-fundraising articles to Amy Rock for inclusion in future **newsletters**.

Special Events

Paul Hartranft provided an update on the Tri-Bay Golf Outing. As discussed during the previous meeting, sponsorship is down from last year while the number of participating golfers is up. Paul stated that anyone who wants to golf, but has not yet registered, needs to attend to this immediately.

Distinguished Alumni Awards

Paul Hartranft and Scott Maloney **have both received** nominations for the Distinguished Alumni Award, although some of these nominations only include **the person's name** with no supporting information.

This was followed by a discussion of the nominating committee and why two Bay High students will be on the committee (the two students will be the Junior and Senior class presidents). During the formulation of the nominating procedures, it was felt that having two high school students would serve to get students better connected to their alumni foundation **and provide the nominating committee with a better overall mix**.

Diana Lee volunteered to be on the nominating committee and Scott Maloney and Judy Norton will be the trustees participating on the committee.

Paul Hartranft stated that he would contact Fred Drenken and George Serb to see if they would like to serve on this committee. Ike Ganyard added that Bob Kitzerow would be a good **committee member when nominating teachers/administrators**.

Scott Maloney added that a meeting of this committee would be held during the second half of June and that he would notify members of the time and place.

Hall of Fame

Ike Ganyard informed those present that the sign above the Alumni Hall of Fame is now up and that the entire project is moving forward in the right direction. Ike discussed a vendor, Vista Imaging, which may end up designing and manufacturing the plaques for the hall of fame. He added that, because of the poor quality of some available pictures, it would be preferable to incorporate pencil sketches of inductees into the plaques. Ike presented some dollar figures and the cost for one plaque may be in the \$200 range.

If anyone knows of Bay alumni who might be interested in creating these pencil sketches, please contact Ike. Scott Maloney offered to talk with members of the art department to see if they know of someone who could fit this bill. Ike hopes to have a prototype plaque ready for **the next meeting**. All that is needed is a decent pencil sketch artist.

New Business

Paul Hartranft discussed the "History of Bay Village" presentation that he, George Serb and Fred Drenken gave to second graders in May and what a pleasurable experience it was.

There was a discussion about the decommissioning of Forestview School and what items may have been saved. There are no plans for this site at this time. Jane Rock suggested ordering **Forestview School Cat's Meows for fundraising purposes, but deferred** discussing this to the

meeting.

Bart Rippl stated that he needs to update the Alumni Foundation Contact List due to the **involvement** of new members. The FBI may be brought in to consult on this matter if information is not provided in a timely fashion.

Finance

Committee

Since there was no sit-down meeting for July, Jane Rock submitted the treasurer's report dated 13 July. She pointed out that, compared with 2003, there was less money taken in for the Tri Bay Golf Outing, yet more money was spent on giveaways (hats, etc.). As of 13 July, the total funds belonging to the foundation were \$3,813.16. For the 3 August treasurer's report, additional funds were received in the interim. Total belonging to the foundation as of 3 August was \$5,426.24

Scott Maloney asked whether the foundation should order Forestview School Cat's Meows as a means of fundraising. He added that an article would appear in the August newsletter to get a feel for any interest on this. Scott added that the Distinguished Alumni Award recipients will be announced in the August newsletter. Furthermore, Scott mentioned that he needs to get with Lori Sisto on any announcements regarding Homecoming for the August newsletter, which should go out around the middle of this month.

Special Events

Paul Hartranft mentioned that his class ('64) will be having their reunion on 9 October at 6 p.m. at the Westlake Dave & Buster's. Distinguished Alumni award recipient Richard North Patterson will be in attendance. Paul and Bart Rippl coordinated introduction responsibilities. Paul will introduce Mr. Patterson at Dave & Buster's and Bart will do the high school assembly introduction of Mr. Patterson along with any introduction for Arthur Hook.

Art Hook is having his Class of '49 reunion on 25 September. It remains undecided whether or not he will receive his award at their reunion on Saturday or during the Sunday brunch. Bart Rippl has been in contact with Class Rep Lou Petto and she will run this by the class committee for consideration and get back with Bart.

Homecoming is scheduled for October 8, 2004.

Distinguished Alumni Awards

Scott Maloney announced that Richard North Patterson (64) and Arthur Hook (49) are recipients this year of the Distinguished Alumni Award for inclusion in the Alumni Hall of Fame. A third nominee, Cindee Matyas Woltjer, was tabled pending receipt of additional information. The announcement of Richard and Art will be included in the August newsletter.

Jane Rock mentioned the surplus Bay High fundraising clocks and what should be done with them. It was suggested that they could be offered for sale at this year's homecoming football game or the foundation could possibly make arrangements to have them sold for the foundation at the Bay sportswear shop next to the bleachers.

Hall of Fame

Ike Ganyard inquired about how much the foundation wanted to spend on Hall of Fame construction, which includes the backdrop along with a set number of pre-paid plaques. He presented the foundation with two choices: (1) approximately \$15,800 for the larger plaques and (2) approximately \$9,500 for the smaller ones. Once the selection has been made, engraving of plaques for inductees will cost \$45 each. Ike presented the foundation with samples of both the large and small plaques. Consensus wavered during this meeting between the small plaques, to save costs, and the larger ones, which look much more professional.

Scott Maloney suggested contacting the class reps which correspond to the classes for which the foundation is holding money and asking them to donate these funds towards

the construction of the Hall of Fame. Scott stated that he will write them letters to this effect.

It was also suggested that Ike have the artist rendering of the proposed Hall of Fame blown up into presentation format. This would allow the foundation to present this rendering in the alumni tent at homecoming with the hope of garnering additional donations towards construction costs.

The foundation decided to have approximately 4 to 5 larger plaques produced.

While there was no quorum of trustees at this meeting, consensus was generally in favor of constructing the Hall of Fame to accommodate the large plaques.

Paul Hartranft said there was little success in getting alumni, other than those from the class of '64, to stop by Bay Lodge following the homecoming football game. Paul also acknowledged Ike Ganyard for setting up the Hall of Fame display for his class reunion at Dave and Buster's.

Ike Ganyard mentioned that the foundation needs to look into getting new signs for homecoming and other events. Bart Rippl stated that he works with several sign companies and would be willing to get three quotations on new signs. It was generally agreed that the signs should read "Bay Alumni Foundation" and should also include the Bay logo. The suggested size was approximately 4' X 8', although Bart will get recommendations from the various sign companies who will bid on this job. Al Nelson also mentioned the appealing wooden structure which the Bay High cross country **team used** for their float and suggested that the Alumni Foundation develop an idea for something similar to use on the Alumni Foundation float for next homecoming. Al volunteered to build such a structure if someone can come up with a good idea. He also suggested that Sally Price **be recruited to develop a design.**

Hall of Fame/Distinguished Alumni

Awards

Al Nelson and Ike Ganyard recently traveled to Minster, Ohio to visit Partners in Recognition, the company which will be constructing the Hall of Fame. Ike pointed out that he had this company rearrange the original proposal to take one row of plaques from each cell in the hall. This would bring the total number of plaques down from 72 for alumni to 60 plus another 18 for distinguished educators (total 78). The revised proposal will also alter the color scheme from all white plaques to 1/3 white, 1/3 light blue and 1/3 dark blue. Ike showed an artist's rendering of this revised proposal. Ike also pointed out that Partners In Recognition requires **no down payment** on this project. Upon being given the go-ahead, it will take them 4-6 weeks to complete the hall and payment is due upon completion. The total cost for the project is \$15,644.55.

Jane Rock inquired about the payment. Amy Huntley interjected that we could get a P.O. from the school district for the total cost and then reimburse the district for the foundation's

share. Amy also said that we could use "Coke Machine" funds and that the Superintendent of Schools (Clint Keener) stated to her that the Hall of Fame would be a good use of this money. Amy also said that she would take Ike's recent proposal (total cost figures, etc.) to Mr. Keener, **as he requested hard** numbers on this project. Amy said she didn't know how soon she would **have an answer** from Mr. Keener, but added that she'd talk with him on this matter within the next couple of weeks. Al Nelson suggested that Ike should get in touch with Partners in Recognition and inform that we should have a decision on this project by the beginning of **December**

Al Nelson suggested to Amy Huntley that work should commence on a Sports Hall of Fame **and** that she should mention this to Mr. Keener **when they next speak**. Amy mentioned that the Rockets Association is working on this and that the Sports Hall of Fame would be financed completely by corporate sponsors.

Ike Ganyard asked for volunteers to locate photographs of the following Distinguished Alumni award recipients: Patty Wendling, Sally Irwin Price, Mary Woodward, Richard Mackey, John Parker, Nancy Farmer, Kirk Shepard and J. Frederick Grassle. Al Nelson volunteered to get a photo of Patty Wendling.
